## Making Headlines

#### Rebuilding School & Classroom Libraries in Louisiana



This is Glen Oaks Park Elementary, where first grade teacher Aimee Manzella Lastner lost the classroom library she's built over the past four years. Her school is set up at a dry temporary location now and would appreciate donations of new and like-new books for grades K-2.

Author Kate Messner writes, "If you're like me, you've been watching the news out of Louisiana and wanting to do more to help. When whole communities are flooded, families who have lost everything are uprooted, and that can be especially tough on kids. As a result of flood-damaged schools, many students have also been displaced from their classrooms for now, and teachers & librarians have lost books and supplies. Let's make sure those kids have beautiful books in their school and classroom libraries when they return.

**For Flooded Schools & Libraries:** Here are two resources that have been brought to my attention that may be helpful to you. Check out <u>Beyond Words</u>, the ALA's relief fund with Dollar General and <u>The Lisa Libraries</u>, which donates books to organizations that work with kids in poor & under-served areas.

For People Who Want to Help: Not all schools are ready to accept book donations right now, so donating money to this disaster relief fund set up by the Association Education Professionals of Louisiana is one great way to help.

"Some schools that lost classroom libraries *are* ready to receive donations of new and like-new books to replace classroom libraries now. Please follow the guidelines carefully so we don't inadvertently create more work for people who are already buried in it.

particular Division to communicate with other statewide divisional members.

As part of the restructure, our former Interest Groups are now known as Sections of WLA, and may be joined by members of any WLA Division. All of your favorite IGs are still there, with one notable change. In late 2014, members of the Washington Library Media Association, at the time its own, separate Association, voted to become an Interest Group of WLA. Then, as part of the WLA reorganization vote earlier this year, WLMA was "promoted" to become the School Libraries Division, one of WLA's four pillars of service and representation to the WA library community. If you are a current member of the WLMA Interest Group, you will automatically have your membership rolled over into the School Library Division. No action is necessary on your part until it's time to renew your WLA membership.

## What does WLA's reorganization mean to your membership status?

Beginning September 1, when you join WLA or renew your membership, you will be asked to select a WLA Division at no extra charge. If you wish to join additional WLA Divisions, those may be added for a nominal fee of \$5 each. Section memberships continue to be \$5 each, as well. The WLA Finance Committee will be assessing WLA's overall pricing structure in the coming months in order to make recommendations on what changes are necessary to better reflect and support our new organizational structure.

# PLA Leadership Academy Now Accepting Applications

The Public Library Association (PLA) is currently accepting applications for the PLA Leadership Academy: Navigating Change Building Community, March 20-24, 2017, in Portland, Oregon. This special event will offer intensive, empowering leadership education for public librarians who want to increase their capacity to lead not only within the library, but also in the community.

Developed in collaboration with the International City and County Managers Association (ICMA), and supported by a grant from the Institute of Museum and Library Services (IMLS), the Leadership Academy consists of:

- A professional coaching program with experienced public library leaders and city managers; and
- Development of real-world projects to implement at attendees' libraries.
