Washington Talking Book & Braille Library Named Network Library of the Year



For the second time this decade, the <u>Washington Talking Book & Braille Library</u> has received top honors for its outstanding services to readers who are visually or physically impaired.

The National Library Service for the Blind and Physically Handicapped, part of the Library of Congress, presented Director Danielle Miller with the 2016 Network Library of the Year Award in the Library of Congress' Jefferson Building in Washington, D.C. Washington Talking Book and Braille Library previously won the award in 2010 and has been selected this year for its commitment to outreach and to engaging readers in the local community.

# Washington's State Art Collection Is Now Online at My Public Art Portal

For the first time, a physical inventory of the entire State Art Collection is being undertaken by the Washington State Arts Commission since its beginnings in 1975. More than 2,000 of the ArtaWA collection's 4,500 artworks are included, and more are added every week. This inventory work ensures that the information presented online via My Public Art Portal is accurate, complete, and supported by current photography. It also helps prioritize conservation work and supports the overall care of the Collection, which is located at K-12 public schools, colleges, universities, and state agencies throughout Washington.

ArtsWA partners with educators to create a custom group of artworks in My Public Art Portal, to be used as a teaching tool or to complement any lesson plan or lecture.
